### Cyprus

Cyprus is the third largest island in the Mediterranean Sea. Cyprus is a modern country that enjoys a strategic geographical location. It lies at the crossroads of three continents, Europe. Africa and Asia, thus provides unrivalled access and travel opportunities and excellent flight connections.

The island through its rich history going back more than 10.000 years, has developed from a Stone Age settlement to a modern and thriving European Union State.

Cyprus is a full member of the European Union since 2004 and a member of the Commonwealth.

Cyprus offers a multicultural environment as 20% of Cyprus' population is foreign nationals. As an ex-British colony, Cyprus enjoys an efficient and transparent British-based legal system.

Key factors that make Cyprus an attractive destination for investment are the highly specialized human capital, the reliable legislative and regulatory framework, the stable tax system and the safety and stability conditions prevailing in the country. Cyprus has developed a robust, market-driven economy supported by an excellent system of infrastructures and telecommunications.



## **Cyprus EU Citizenship**

Cyprus is one of the most popular European destinations for non-EU nationals. Over the last few years, Cyprus has attracted many third country nationals from around the world who applied and successfully obtained the Cyprus citizenship.

Cyprus is currently one of the very few countries within the European Union which by law offers the Cypriot and subsequently the European Union citizenship and passport in a short period of time. The Cyprus naturalization by investment scheme is considered the most straightforward route to becoming a European citizen.

## Cyprus Citizenship combines the following benefits:

- Free movement, residency and work within the EU;
- Favourable tax regime;
- Fast track application and efficient procedure to obtain the citizenship;
- No requirement to live in Cyprus before or after obtaining the passport;
- No language competence requirements;
- Ease of travel to more than 150 countries in Europe, Asia, Middle East, Africa and internationally with no visa required or visa on arrival;
- Dual citizenship is allowed;
- Citizenship can be passed on to the next generation;



- No restriction on nationalities;
- High standards of international schooling and universities;
- Access to modern medical facilities and healthcare systems;
- A renowned international business and commercial centre operating as the bridge between East and West and the gateway to the European Union;
- An efficient and transparent British-based legal system and business infrastructure;
- English is widely spoken.

## Cyprus offers a favourable tax regime:

- No wealth, gift, inheritance or foreign income tax;
- No capital gains tax (exemption: gains from the disposal of immovable property situated in Cyprus and gains from the disposal of shares in companies owning such immovable property are taxed at the rate of 20%)
- No personal income tax as there is no requirement to become a Cyprus tax resident;
- Low personal income tax in cases where the individual wishes to become a Cyprus tax resident;
- No restriction on the repatriation of profits and imported capital;
- Transfer fees are reduced to 50%. No transfer fees are imposed for the transfer of property that is subject to VAT.



#### **The Revised Criteria**

On the 13/09/2016 the Council of Ministers has introduced a Decision amending the criteria for acquiring the Cyprus Citizenship by Investment. The main amendments relate with the reduction of the minimum investment amount to  $\leq 2$  million and the inclusion of the investors' parents. On the basis of the new conditions a non-Cypriot citizen who meets one of the below financial conditions can apply for the Cyprus Citizenship:

- A. Invest at least €2 million for the purchase or construction of immovable property or development creation such as residential or commercial developments, developments in the tourism sector or other infrastructure projects; or
- B. Invest €2 million in order to purchase, create or participate in businesses or companies based and operating in the Republic of Cyprus. These businesses or companies must have a physical presence in Cyprus, substantial activity and a significant turnover and must also employ at least 5 Cypriot citizens or European Union citizens who during the five years preceding the filing of the application were residing in the Republic of Cyprus; or
- C. Invest at least €2 million in Alternative Investment Funds established in Cyprus, licensed and supervised by the Cyprus Securities and Exchange Commission and exclusively making their investments in the Republic of Cyprus.
- D. The applicant may proceed with a combination of the above, provided that the total investment will amount to a minimum of €2 million.
- E. In the context of combining investments the applicant may also purchase special government bonds of the Republic of Cyprus of up to €500,000.



In all the cases listed above (A-E) the applicant must hold a permanent private residence in the Republic of Cyprus, with a market value of at least  $\in$ 500.000 plus VAT. If the market value of the residence exceeds  $\in$ 500,000, part of the additional amount can be used to complete the amount of the investment. In cases where the applicant invests at least  $\in$ 2 million in one or more residential properties then the applicant is not required to further purchase another residence.

Moreover, the applicant must have a clean criminal record, and his name must not be included in the list of persons whose assets, within the boundaries of the European Union, have been frozen as the result of sanctions.

Prior to the naturalization as a Cypriot citizen, the applicant must hold a residence permit in Cyprus for a period of 6 months. If the applicant does not hold a residence permit already, he may submit an application for the residence permit simultaneously with the application for the Citizenship.

#### **Family Members**

The Decision of the Council of Ministers dated 13.9.2016 provides for the grant of the Cypriot citizenship to:

- A. The spouse or partner of the investor;
- B. To the parents of the investor;
- C. To the financially dependent adult children of the investor up to the age of 28; and
- D. The minor children of the investor (under 18).



#### Permanent Residency in Cyprus

The Residence Permit (Fast Track) under the Regulation 6 (2) of the Aliens and Immigration Regulations combines an extremely straightforward process and simple criteria with no language competency or nationality restrictions. The program is unique in that once the permits are obtained they are valid forever, with no requirements for renewal.

The Permanent Residence Permit applies to:

- The applicant;
- The spouse;
- Unmarried dependent children up to the age of 25;
- The applicant's parents and parents-in-law.

The holders of the residence permit are not required to reside in Cyprus; a visit once every two years is sufficient. With the permanent residency status the holders can live freely in Cyprus or continue to live in their home countries and use the permit whenever they need it. The residence permit can act as a safe plan for the future. It also gives the opportunity to apply for Cyprus (EU) citizenship after 7 years.



#### Legal requirements to obtain the Fast Track Permanent Residence Permit:

- a) Purchase of new immovable property/properties with a value of at least €300,000 (excluding VAT) out of which €200,000 must be paid before applying for the Residence Permit.
- b) Fixed deposit of €30,000 in a Cyprus bank account pledged for 3 years.
- c) Secured annual income deriving from abroad (salaries, pension, rentals, dividends) of €30,000 plus €5,000 per dependent, plus €8,000 per parent and parent-in-law.
- d) Declaration that the applicant and the dependents shall not work or engage in any business in Cyprus, other than owning a company.
- e) Clear criminal record certificate for the applicant and the dependents over 16 years old.

The application will be examined by the Civil Registry and Migration Department and shall be submitted to the Minister of the Interior for a decision. The examination period takes around 2 months.



#### Long-term residency

"Long-term residency" status enables applicants to enjoy similar rights to EU citizens, including the ability to work, study, and operate a business. "Long-term residency status" is permanent and available to all non-EU nationals that have resided in Cyprus for over 5 years as long as they have not been absent for over than 6 consecutive months or more than 10 cumulative months within the 5-year period.

## **Family Reunification**

Ascendants and second line relatives of permit holders can visit or reside in Cyprus according to the Cyprus legislation. Family members wishing to visit for holidays will be granted with a three-month visa while those wishing to reside in Cyprus can apply for a one-year temporary permit (pink slip) which is annually renewable.



#### **Business**

Any individual, Cypriot or non-Cypriot, including Passport or Residence Permit holders, may set up a company in Cyprus and benefit from the low corporation tax of 12.5% on net profits; or use a Cyprus company as an intermediary for export and trading activities from their home countries and take advantage of the zero (0%) tax on dividends for non-tax residents.

#### **Income Tax**

Anyone spending less than 183 days in Cyprus within one calendar year is considered non-taxresident and is tax liable only on income derived from Cyprus, excluding dividends.

#### Banking

An individual or corporate bank account can be opened without visiting the Country. E-banking and credit and debit cards are provided. Many foreign banks from the Middle East, Europe and Asia operate subsidiaries, branches or representative offices in Cyprus. Cyprus banks offer an array of services ranging from asset management, private banking, international, corporate and investment banking, retail banking, syndicated loans, custodian services and more.
